# **Brainspotting: Trauma Therapy that Works Presenter: Lisa Larson, LMFT**

"Brainspotting" is a powerful, brain-based trauma therapy that accesses the deepest regions of the brain where clients store their traumatic experiences and survival terror. This access to the limbic system and brainstem allows deep transformation to occur. It works by identifying, processing and releasing core neurophysiological sources of emotional and body pain, trauma, dissociation, terror, flashbacks, panic, and other challenging symptoms. Symptoms of unprocessed trauma, which include chronic anxiety, insomnia, and numbing, are notoriously difficult to eliminate through talk therapy. This is because the brain becomes overwhelmed and is unable to process verbal information about the traumatic events.

"Brainspotting" was voted the most effective trauma treatment by the parents and survivors of the Sandy Hook massacre after a five-year study by the Sandy Hook Foundation comparing over 25 therapeutic modalities. The parents rated it first in its effectiveness in treating the traumatic loss of their young children.

This presentation teaches participants to metrically measure the efficacy of each session with their clients so it is very clear if the client is benefiting from the treatment. It also will help the attendees stay abreast of the most recent brain-based breakthroughs in treating clients with PTSD. This presentation underscores principles of complete non-judgment and compassion for each and every client. It also encourages the therapist to follow the client, rather than lead.

I feel extremely grateful to Tara who developed new protocols for paying bills using the bank's bill pay, backed up by email approvals which kept Board members safe from needing to get together to sign checks, and mail bills. She helped get training to the Board for the technical aspects of Zoom, which she and Patrick Armstrong, our Programs Chair, and Director at Large, needed to create online events for our members. She rose to the occasion and saw us through one of the most difficult years of our lives. Three cheers for Tara!

Back in March 2020 we were all so scared, wondering what was to come. As a Board, we realized our promise to our members was to provide 15 CEs a year, and at that point we had completed 4.5 CEs with our first three meetings. Patrick Armstrong, assisted by the Programs Committee, Michael Krikorian, and Gina Culver (who volunteered to become the Programs Committee Co-Chair), arranged for some terrific speakers in the fall. In October we had internationally renowned sex therapist Marty Klein for 6 CEs at no charge to our members. Marty gave a fascinating presentation on the challenges of working with couples in 2020. In November we had a dynamite 3 hour presentation by Barbara Griswold, bringing us up to date on telehealth and insurance billing during a pandemic. December provided RECAMFT members with a fascinating 3 hour presentation by Suzanne Alfandari on motivational interviewing. We finished 2020 with 14.5 hours of training offered to our members. We were 0.5 hours short of our usual offering. Not bad considering we were coping with Covid-19, a new way of doing business and interacting with our clients and each other, and multiple wildfires terrorizing Sonoma County.

In 2021 Patrick and Gina plan to make up that extra half-hour and then some! We have 2 and 3 hour presentations planned this spring, and we will be ahead of our usual CE schedule by the time June rolls around. We plan to offer 6 hours of Law & Ethics in 2021 when we can square the dates away with CAMFT staff attorneys.

Unfortunately, our 2020 President Elect, Kira Kayler, needed to resign in December. This left the Board with some difficult considerations for who would run for President Elect, knowing this person would immediately become Acting President in 2021. I decided it was time to call in the big guns. I phoned Bob Casanova, the former "King of CAMFT" (as he was affectionately referred to by me) and told him I needed him to join the Board, if I was to undertake the job at hand. Luckily, he said yes. He brought in Victoria Rohrer, who volunteered to take over my previous role as Secretary (yay Vicky!). RECAMFT's CFO, Erica Thomas, moved out of the area in December, so the Board's first task will be to appoint a CFO to a oneyear position for 2021. We have a paid bookkeeper, and a tax accountant, so check writing, and supervising are the main responsibilities of our CFO. We need you right away. Please step forward and introduce yourself ASAP! In 2014 I was the President of RECAMFT. It was an exciting time, as I ran with Bob Casanova, and several other folks from the Save CAMFT group, in a fully contested election after being petitioned onto the ballot by our colleagues, to become the President Elect of CAMFT. I served as the 2015-2016 President of CAMFT. Bob Casanova was the 2017-2018 CAMFT President. I have seen CAMFT chapters all over the state, and one thing I know is this RECAMFT chapter is unique in that it attracts unusually marvelous people. A great example is Gail Van Buuren who was RECAMFT's President in 2007 and has continued on as our Newsletter Editor and unofficial historian for 14 years. During the Board's holiday Zoom party, new Director at Large Jean Hayes shared her history including training with Virginia Satir, and Carl Whitaker, even accompanying Carl to the Soviet Union to train family therapists. I love thinking about how Virginia and Carl will bless our work through Jean's fortunate synthesis with the spirit of the RECAMFT Board.

Relying on our savvy Past President Tara D'Orazio, and the strength of this incoming Board, I hope to be a capable Acting President in 2021, and President in 2022. If ever there was a time we needed each other, last year has brought home that lesson. I hope 2021 will see us

eventually able to come together once again in celebration as a community by the year's end. The RECAMFT membership has been a shining beacon in the state CAMFT chapter community, and we are leaders who rose to the challenges of the wildfires in our county to shine that light on trauma survivors, and the need for crisis mental health counseling. It is my deepest honor to give an encore performance at the helm of our ship as we sail with our most treasured cargo — a preeminent group of world-class healers — all of you, our RECAMFT members! Bon voyage!!
